This document constitutes anon-binding agreement between the Goa - Center of Excellence Intellectual Property (G-CEIP) in association with Goa College of Pharmacy (GCP), institutes promoting education and training in Intellectual Property (IP) in the discipline of across sciences and, with a head office at Goa College of Pharmacy, 18th June Road, Panaji, Goa, INDIA and PACIFIC ACADEMY OF HIGHER EDUCATION AND RESEARCH UNIVERSITY (PAHER), Debari, Udaipur, Rajasthan, INDIA, engaged in IP activities with a head office at Pacific Hills, Pratapnagar Extension, Airport Road, Debari, Udaipur, Rajasthan, INDIA.

1. Objective

The objective of this MoU is to express the willingness of both parties to engage in an effort to achieve several main objectives to induce the spirit of inquiry in translating theoretical science into innovative products:

- Certificate Professional Advancement Programs (CPAP) - courses of varying duration for students and faculty enrolled at PAHER and other institutions across the state of Rajasthan to obtain training and direct experience ("field work") in the areas of intellectual property rights (IPR), regulatory affairs and product development.
- Series of Workshops, each of two days and up to five days duration to provide continuous update and upgrade of knowledge base in IP.
- Provide Intellectual Property (IP) Services for IP generated through research work.



2. General Terms of MoU

Both parties agree to carry out the above-mentioned activities in accordance with laws and regulations of respective states after full consultation and approvals.

With respect to the hosting of the members of G-CEIP and PAHER, Udaipur, Rajasthan:

- PAHER agrees to cover local hospitality only to the GCP and G-CEIP members for visiting the Institution.

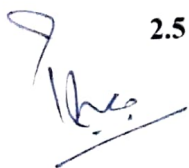
2.1 Duration of MoU: This MoU shall be operational upon signing and will have an initial duration of FIVE YEARS (February 8, 2025 through February 7, 2030). All activities conducted before this date within the vision of the joint collaboration will be deemed to fall under this MoU.

2.2 Coordination: In order to carry out and fulfill the aims of this agreement, the parties will appoint appropriate person(s) to represent its organization and to coordinate the implementation of activities.

2.3 Technical and Financial Support : PAHER will be responsible for providing any needed technical support to the participants. This includes, e.g., internet (Wi-Fi) access, access to scientific literature, etc. At least initially, there will be no financial contributions required of any party to the other. As such, any financial contribution by one party to another will be carried out at its sole discretion.

2.4 Confidentiality: Each party agrees that it shall not, at any time, after executing the activities of this MoU, disclose any information in relation to these activities or the affairs of business or method of carrying on the business of the other without consent of both parties.

2.5 Termination of MoU: The partnership covered by this MoU shall terminate upon



completion of the agreed period. The agreement may also be terminated with a written one month notice from either side. In the event of non-compliance by one of the parties of the obligations upon it, the other party may terminate the agreement with immediate effect.

2.6 Extension of Agreement: The MoU may be extended provided the parties agree upon and can provide the necessary resources.

2.7 Communications: All notice, demands and other communication under this agreement in connection herewith shall be written in English language and shall be sent to the last known address, e-mail, or fax of the concerned party. Any notice shall be effective from the date on which it reaches the other party.

2.8 Addendum: Any Addendum to this MoU shall be in writing and signed by both parties.

3. Other Provisions

3.1 Each party shall pay the costs of its staff and any fees associated with the participation of its staff (e.g., transportation, meals, communications, lodging, etc.) in the support of this activity.

3.2 PAHER will have no other legal and/or financial obligations to GCP and G-CEIP.

3.3 Income tax and VAT, if any, arising due to fees received by PAHER, G-CEIP or GCP from the participants shall be borne by PAHER, G-CEIP or GCP, respectively.

3.4 Both parties assume that this agreement does not go against the rules and regulations of the Government of the United States or Government of Goa, Government of Rajasthan and Government of India.

Unless otherwise specified, the terms and provisions in this MoU also apply to any subsequent Addendum to this agreement.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FOR THIN THIS MoU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1 : CO-OPERATION

Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching /training systems, keeping in mind the needs of the industry, the Second Party.

The general terms of co-operation shall be governed by this MoU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter in to all relevant agreements, deeds and documents (the Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MoU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MoU shall represent the entire understanding as to the subject matter here of and shall supersede any prior understanding between the Parties on the subject matter here of.

CLAUSE 2 : SCOPE OF THE MoU

The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industries. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

Second Party will provide integrated training on Good Manufacturing Practices (GMP), Good Laboratories Practices (GLP) and Good Documentation Practices (GDP) to the students of first party via online/onsite mode which will help the students to enter in the fields of – Pharmaceuticals and Cosmetics Industries and fit into the industrial scenario meaningfully.

There is no financial commitment on the part of the Pacific College of Pharmacy, Udaipur, the First Party to take up any program mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

CLAUSE 3 : INTELLECTUAL PROPERTY

Except as expressly provided herein or otherwise in writing by both Parties, this MoU does not grant or authorize either Party any ownership rights or interest in the other Party's trade name, trademarks or copy rights, or any intellectual property work.

CLAUSE 4 : VALIDITY

This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **Heltreich Institute For Professional Studies, Udaipur**, the Second Party, as the case may be, will take effective steps for implementation of this MoU. Any act on the part of **Heltreich Institute For Professional Studies**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MoU.

Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

CLAUSE 5: RELATIONSHIP BETWEEN THE PARTIES

It is expressly agreed that **First Party** and **Second Party** are acting under this MoU as independent contractors and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in anyway, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

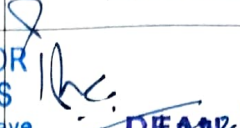
Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of

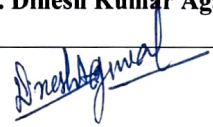
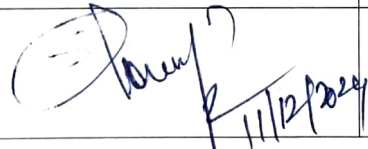
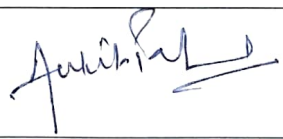

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter "MoU") is made and executed on 24th day of October, 2024 at Udaipur, Rajasthan, India.

BY AND BETWEEN

PACIFIC ACADEMY OF HIGHER EDUCATION AND RESEARCH UNIVERSITY (PAHER),

an University registered under the laws of India having its registered office at Pacific Hills, Pratap Nagar Extension, Airport Road, Debari, Udaipur, Rajasthan (India) – 313024, hereinafter referred to as "**PAHER**" (Which expression unless repugnant and contrary to the context, shall mean and include its dean, directors, administrators and assigns). **Herein referred as First Party.**

and

CHEMROBOTICS PRIVATE LIMITED,

a company incorporated and validly existing under the laws of India and having its registered office of business at its principal office at ChemRobotics House No. 09, Ward No. 23, Jawahar Ganj, Dabra, District Gwalior, Madhya Pradesh 475110, India. **herein referred as Second Party.**

PAHER and **ChemRobotics** may be referred to herein individually as a "Party" and collectively as "Parties"

And whereas, to facilitate Skill India program for student, **PAHER University** and ChemRobotics have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the cooperation of the two institutions set out in the following sections.

IT IS HEREBY AGREED by and between the parties hereto as follows:

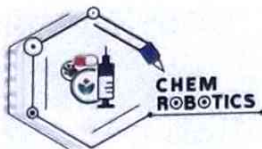
1. PURPOSE:

1.1 The objective of this MoU is to nurture the professional skill to the students by facilitating training and internship by co-operation between the parties in the field of Scientific Data Science including Intellectual Property specially Patents, Chemistry, and Formulation. Further, the parties agree to achieve common objectives relating to IPRs, which inter-alia includes:

- a. Skill development** - provide internship to student with certification and stipend

- b. Create a conducive IP ecosystem for the first party and stakeholders thereof which are including but not limited to colleges, incubators, incubates, students, professors etc.
- c. Promotion of public awareness of protection of IPRs.
- d. Maintain a transparency throughout the enforceability of this MoU.

2. SCOPE OF CO-OPERATION:

- 2.1 The second party mentioned herein agrees to provide internship to student for the professional development, featuring challenging projects in Intellectual Property specially Patents, Chemistry, and Formulation, along with mentorship from seasoned industry professionals, involvement in pioneering initiatives and an initial stipend of depending in the caliber and performance of the candidate.
- 2.2 Provide internship to student with respect to IPR, regulatory, technical know in Pharma, Veterinary, Agrochemical, Fine Chemical segments. The training also includes the data mining, data compilation, making review reports, scientific article, book writing, etc.

Interns will get certificates after completion of training and examination.

3. ENFORCEABILITY:

- 3.1 The said MoU will enter into the force on the day following the date of its signature for a duration of three years, with an aim to being renewed, subject to the Parties' mutual agreement.

4. CONFIDENTIALITY:

- 4.1 The Parties acknowledge that the existence and all the terms of this Agreement including any amendment to this agreement / any separate agreement to be executed hereinafter and any oral or written information exchanged between the Parties in connection with the preparation and performance of this Agreement are regarded as confidential information.





- 4.2 Both the parties hereby undertake that they shall not at any time during the continuance in force of this Agreement or any time later divulge any information in relation to the other party's affairs or activities especially to any third party nor disclose such information to any third party except as may be required in carrying out the terms of this Agreement hereto solely and/or for the purposes of rendering services pursuant to this Agreement and shall only be so provided with the prior written consent of both the Parties.

5. OWNERSHIP AND INTELLECTUAL PROPERTY RIGHTS:

- 5.1 All Parties agree to respect each other's rights to intellectual property. All proprietary information, copyrights, trademarks, trade names, logos and any other intellectual property of each Party shall remain the exclusive property of that Party only.
- 5.2 Except as expressly provided herein or otherwise in writing by both Parties, this MOU does not grant or authorize either Party any ownership rights or interest in the other Party's trade name, trademarks or copyrights, or any intellectual property work.

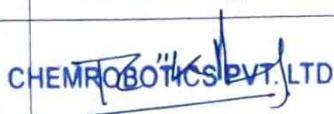
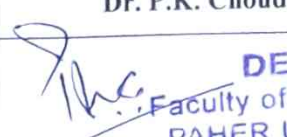
6. RENEWAL, TERMINATION AND AMENDMENT:

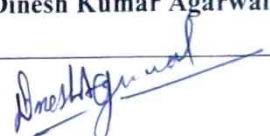
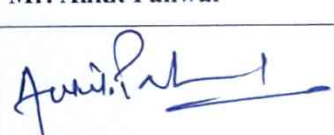
- 6.1 The parties hereby agree that this MoU shall remain in force for a period of **THREE** years from the last date of signature. The period can be extended upon written agreement by the parties upon mutually agreed terms and conditions.
- 6.2 The parties hereby agree that this MoU may be terminated by giving a prior written notice at least three months in advance before the date of termination. However, any activities which is being conducted under this agreement or any separate agreement shall continue to be conducted by the Parties notwithstanding the termination and in respect of those activities' terminations shall take effect only upon the completion of those activities.
- 6.3 Any amendments and/or modifications of this MoU, made by mutual agreement between the Parties, shall be submitted for prior approval of the delegated authorities of the Parties.





- 6.4 Either party may terminate this MoU at any time by issuing/giving at least 90 calendar days' written notice to the other party. The early termination of this MoU will not affect the completion of any co-operation measures that were agreed for on-going projects whilst it was in force.
